Adequate funding for Education.

15 What are your views on state tax policy (75 words or less)?

I did not vote for what the governor called the 'nuclear option' tax cut package. We had a well balanced tax approach and making small incremental changes that make sense to business growth policy makes sense. We have to balance all three, income, property and sales taxes. What I fear is that we have cut income taxes which means more will fall on the sales and property taxes. As far as I know property taxes are the least liked by the public.

I would propose we redo last year's tax package.

I introduced legislation for those whose spending per pupil is below average be able to spend their own money to get within 80% of average.

Yes, I supported that in the legislature and we voted to do just that.

While I have voted for most all of them, I would like very much to get an accounting of exactly how many jobs have been created by each. We need to be able to expand what works and do away with what is not job creating.
